- Invited Kolbie Singleton to pick up dump passes for residents who could use his services in removing dump items to help blight issues.

- Have reserved the month of September with the dump dependent on how numbers for April come back.
- Millage for Concession Stand/Restroom/Storage Area at the Tiger's Den; Proposing Millage language at Thursday, April 11 meeting for 0.5 mil to cover Youth Rec Program. Would be for 3 years and bring in approximately \$72,000 year 1, \$75,000 year 2, and \$77,000 year 3.
- Applied for grant with Consumer's Energy for lighting at Tiger's Den but did not get that grant this year.
- Joint application for grant.
- Joint Meeting scheduled; 3rd week of May proposed.

Lawrence Township Emergency Services: Mike Anchor

- Call volume up about 10% from last year, medical calls are down, fire calls are up.
- Fireman statue up in the cemetery.
- Firefighter Auxiliary Breakfast and fundraisers will give all proceeds towards the cemetery memorial.
- \$20k grant for Firefighter Safety Equipment for Michigan will be put towards Air Paks that were already purchased. Also able to purchase new AEDs.
- ISO went down to a 4; 50 % Fire Department, 40% Water, 5% Communication (911), 5% Community Action Planning (fire inspections, flow testing of fire hydrants, etc).
- Mule all setup
- 99k gallons used at the Hilltop fire; billed the insurance company for that.
- Will be focusing on electric vehicles this summer; three trainings for emergency procedures involving electric vehicles.
