- Senior Services is growing; on Monday, 6/10/24, they served over 90 in-house lunches and over 30 deliveries. Hamilton Township currently pays to allow residents to participate in the meals and Decatur Township is bringing this to their board meeting as well.
- Senior Services Upcoming Murder Mystery Train Ride/Dinner coming up; Saugatuck Boat/Dinner Ride also coming up.
- Countywide ORV is going into vote this week. Township is doing a resolution on Thursday to
  open County Road 374, 215 and 365. Village needs a resolution to opt into the County ORV
  Ordinance with all roads open in the Village.

- Housing Update: Matt Sanborn is back as the Housing Committee leader for the Township;

- Down to three medical responders at the Fire Department with only one in the area full-time; requested assistance from Hartford to see if they could give a hand in the coverage area until more people are found. There is a Lawrence resident who works full-time for Medic 1 and is interested in being on the QR Team.

### Lawrence Township Emergency Services: Mike Carpp

- QR responded 26 Medical and 14 Fire calls; cleaning up station at the moment.
- Introduced a new gas card policy to help with monitoring use.
- Chief Anchor goes back to the dr. on the 26<sup>th</sup> for and update on his shoulder.
- James Ivy is out due to a torn rotator cuff from an altercation on duty.
- Less than 5 people go through the ISD Fire Training Program and join the department since he
  was Chief.
- Discovered while cleaning up the fire department that fire reports are behind 17 months.
